Subject:- Re-numbering of Section 12-A of the Principal UGC Act, 1956 as Section "12-B w.e.f. Ist October, 1984- Regarding.

Sir,

I am directed to say that the University Grants Commission (Amendment) Act, 1984 has come into force w.e.f. Ist October, 1984 vide notification No. F. 12-7/84-Desk-U-dated Ist October, 1984 issued by the Ministry of Education & Culture, Govt. of India, published in the Gazette of India, Extraordinary (Part II, Section 3 Sub-Section (ii)). Section 3 of the UGC (Amendment) Act, 1984 provides that in the principal Act of 1956, Section 12-A is to be renumbered as Section 12-B. The effect of the UGC (Amendment) Act, 1984 would be that w.e.f. Ist October, 1984, Section 12-A of the Principal UGC Act, 1956 would read as Section 12 B, which would include the rules previously made under this Section.

This modification is brought to the notice of the University for information and appropriate action.

It is requested that this may be brought to the notice of all the colleges/ institutions within the jurisdiction of your University.

The UGC Act, 1956(as modified upto Ist October, 1984) is being printed. A copy of the UGC Act, 1956 will be made available to the University in due course.
